Mercury is a heavy metal. It occurs naturally in minerals and rocks. Throughout most of human history, natural sources released mercury into the air as a byproduct. More recently, however, human activity has accelerated the release of mercury.

Burning fossil fuels such as coal releases mercury into the air. Eventually, it ends up in soil or in surface water. Mercury in the water convert mercury into methylmercury. The mercury gets concentrated in the tissues of predators like fish as much as several hundred fold. Typically, concentrate more mercury than small fish.

People who eat fish with high methylmercury concentrations can suffer from muscle tremors, numbness, and poor concentration. Pregnant women and children are especially sensitive to its toxic effects. Learning disabilities and developmental delays are common in children who have been exposed to significant levels of methylmercury during development.
