### 1. Explain the types of products governed under the Consumer Protection Act 1999.

*Section 3 Consumer Protection Act 1999* provides that "goods" means goods which are primarily purchased, used or consumed for personal, domestic or household purposes.

It includes the following:

- (a) goods attached to, or incorporated in, any real or personal property;
- (b) animals, including fish;
- (c) vessels and vehicles;
- (d) utilities;
- (e) trees, plants and crops whether on, under and attached to land or not, but does not include choses in action, including negotiable instruments, shares, debentures and money.

It is reasonably clear that only goods which are purchased for private and non-commercial purposes are covered by the Act.

Most household items such as kitchen utensils, electrical appliances and toiletries.

Goods also include:

- articles fixed to the land such as air-conditioners, appliances and furniture.
- Raw materials which are comprised in other products.
- Industrial process products such as potatoes crisps, fried bananas and frozen meat.
- Materials used to construct a building, such as bricks, cement, plasterboard and plumbing.
- Intellectual products such as letters, books, tapes, film and computer software.
- Pharmaceutical products.
- Component parts which are comprised in other products.
